

NOTICE OF VACATION SCHEDULE

This letter is to confirm that Dr. Gupta and I are in perfect agreement with my present regiment of pain management. **Dr. Gupta has made me responsible for my NARCOTIC pain prescriptions**, and has made it very clear that these medications should be **TAKEN EXACTLY AS PRESCRIBED. Under No Circumstances** am I to show up at the office **SHORT or Before the DUE DATE OF MY REFILL. I DO NOT HOLD DR. GUPTA AND HIS STAFF** responsible if I let my medications run out when he is out of town. The medications are my responsibility to take **exactly as prescribed by Dr. Gupta.**

If for some reason my medications should run out or my medications are lost or stolen while Dr. Gupta is out of town, I understand I need to go to a **Pain Management Doctor or the Nearest Emergency Room** and have another Physician temporarily take over prescribing my pain medication. Dr. Gupta has provided me with a list of pain management specialists. **Our ARNP/PA's cannot write prescriptions for narcotics or controlled substances.**

I release Dr. Virind Gupta, Bee Ridge Family Practice, Inc., and the Health and Self Enhancement Center from any liability if I lose my medications, run out of my medications, misuse or abuse my medications, or if they get stolen. I, the patient take complete responsibility for the prescriptions given to me.

Under No Circumstances am I supposed to take any of the medications given with ANY **Recreational Drugs or Alcohol.**

I, the patient understand that **the Bee Ridge Family Practice Staff Cannot Refill Narcotic Medications or Controlled Substances** if you call our office while Dr. Gupta is out of town.

ATTENTION: We are NOT always open on Saturdays and are NOT always open for walk-in hours. Always check on the day you are planning to walk in after 5 PM for any NEW schedule changes for Dr. Gupta.

When Dr. Gupta is away, Physician is **NOT HERE**. Skeleton staff **ONLY** for phone calls for appointments or with questions for the nurse who can be in touch with Dr. Gupta, so that we can get back to you or refer you

The BEST TIME to call the answering service at 203-7536 is in the evening **AFTER 10:00PM.**

If he does not call back after 1 hour, call him a second time.
